POLICY OVERVIEW

FAHS Alumni works with the FAHS to maintain a comprehensive database of information on alumni in accordance with the general needs and expectations of FAHS and the alumni community. The information retained by us is intended exclusively for purposes related to official FAHS/FAHS Alumni business.

It is the mission of FAHS Alumni to support events, programs and communications that will advance the interests of the college and create opportunities for alumni to participate in the life and vitality of the alumni community. In order to provide the best support possible for these initiatives, FAHS Alumni may collect, share or publish information on members of the FAHS alumni community in accordance with the FAHS Privacy and Usage Policy. FAHS Alumni reserves the right to communicate with members of the alumni community through mail, express mail services, telephone, and all forms of electronic communications.

INFORMATION USAGE, TERMS AND CONDITIONS

FAHS Alumni Usage Guidelines:

At no time will FAHS rent or sell an individual's personal information to third parties.

Alumni/User Guidelines:

In addition to the college and university's policies and guidelines, users of the FAHS Alumni online resources must abide by the following specific rules and guidelines:

1. Unauthorized copying, reproduction, republishing, uploading, downloading, posting, transmitting or duplicating any of the material is prohibited.
2. FAHS Alumni authorized users may download or copy any downloadable materials displayed on the FAHS Alumni website or as part of the online services/resources for personal, non-commercial use, provided that you maintain all copyright, trademarks, usage guidelines and other notices contained in such material.
3. Use of information or communication facilitated through the Alumni online/offline resources for any commercial, public, or political purpose is strictly prohibited.
4. Users shall not restrict or inhibit any other user from enjoying any service of the Alumni online system.

5. Posting of, or linking to obscene materials or use of obscene, vulgar, defamatory, profane, or threatening language of any kind, will constitute a violation of these policies governing the use of Alumni system and network of FAHS websites and online resources, and any material that violate the law of the State of Kuwait.
6. Users shall not knowingly upload, transmit, distribute or otherwise publish any materials containing malicious scripts, viruses or any harmful components.

FAHS reserves the right to determine whether the use or misuse of information obtained through any Alumni resource by any person or group is a violation of these policies or is otherwise abusive and further reserves the right to bar access to Alumni online resources and website by any such person or group and to take appropriate action without notice.

FAHS Alumni will only share information with authorized business partners that are not part of the Alumni programs for the explicit and limited purpose of facilitating an Alumni or FAHS – sponsored initiatives. Authorized Alumni business partners must agree to neither repurpose, distribute, nor sell personal information of the alumni community in any form.
9. FAHS Alumni abides by the college and university’s policies for use of student information, and abides to the laws of the State of Kuwait.
10. FAHS Alumni regards bulk email as an efficient and cost-effective channel of communication with its constituents. It seeks to minimize the amount of email it send to members of alumni community.
11. FAHS Alumni makes no representations about the accuracy, reliability, completeness, timeliness of information available through the network of Alumni website, online resources, or other materials, either printed or delivered electronically.
